Dear Members,

I hope that all of you are doing well. These certainly are crazy times. Unfortunately, Florida has seen a substantial increase in Covid19 cases in the past 2 weeks.

We are continuing to operate the club while maintaining the restrictions and guidelines that the governor has imposed in the Phase II Covid-19 reopening plan. Our objective is of course is to keep the marina operating as smoothly as possible while protecting our employees and members. We are launching boats in daily numbers almost as large as the height of season. We will do everything possible to keep our employees and members safe.

Valet parking is temporarily suspended as is handling of cargo to and from and your boat. You may drive into the valet area and drop off your passengers and cargo. I stress that this is temporary and was implemented at the suggestions of multiple physicians who are club members. Employees are aggressively sanitizing the common areas and baggage carts. All employees are always required to wear masks and gloves while working. We have been extremely fortunate that our 30+ employees have stayed healthy.

Every member and lessee has received multiple emails regarding regulations that we all must adhere to until the Covid19 crisis is over. Once again, here are the current status and rules imposed to keep everyone safe:

* 6 people max per boat (if you require more pick them up and drop off at the public boat ramp) * Self-parking in the back lot (you can pull up front to drop off goods but please act quickly so as not to block the front exit)

* Social distancing is a must. Please stay 6 feet away from all employees and/or other members * Restaurant inside seating is limited to 50% (if we reach capacity in any of our dining areas seating will be stopped)

- * Hand sanitizing stations are located throughout property
- * Recommend wearing gloves and masks
- * If you are even feeling slightly ill please stay away to prevent spreading any illness to others.
