

SHYC PRESIDENTS REPORT MARCH 2020

Dear Members,

I hope that all of you are enjoying our beautiful weather this season. We are in the midst of our busiest time of the year and all is well. Daily launches and sales are at their typical March levels and our first quarter has produced solid financial results from every division of the club operation.

After 18 months of effort we have finally received our dock permit to build the walkway to the beach area and the Marriot. The walkway will be from the north launching dock to the existing boardwalk and with greatly improve pedestrian safety. We will also replace the floating docks on the in water slips as you enter our harbor. The bidding process on this project was aggressively negotiated by the Board and we approved a bid that was over \$20,000 less than the initial bids! We anticipate that the project will be started in approximately 45 days and take 3 days to complete. It will not materially affect our normal operations.

One of the most important aspects of running a successful marina operation is having an effective Board of Directors. This year we have 3 Board of Director's seats up for re-election to 2-year terms and 4 candidates running for election to those seats. The following individuals are vying for those seats:
